Dear NCWU Member Organization:

I'm writing to thank you for being a part of NC Women United (NCWU) over the past year and to remind you that membership dues for 2007 are due by **April 30, 2007**. A membership renewal form and return envelope are enclosed. Dues are based on a sliding scale, as follows:

<i>Organization Annual Budget under \$3500</i>	\$35 per year
<i>Organization Annual Budget \$3500 -\$100,000</i>	\$75 per year
<i>Organization Annual Budget \$100,000-\$500,000</i>	\$150 per year
<i>Organization Annual Budget over \$500,000</i>	\$250 per year

NCWU works to achieve full political, social, and economic equality for women across this state. Working with our member organizations, we use a unique mix of grassroots activism, community organizing, legislative advocacy, and engagement in the political process to accomplish our goals. This year, we have two major events to look forward to:

- ★ Women's Advocacy Day 2007 on Tuesday, May 22;
- ★ Our 2007 Legislative Report Card, released this winter.

I also want to share with you some changes we're making to help our member organizations be more involved and engaged in our programs. One work in progress is a total re-design of our NCWU website and e-communication tools to make it quicker and easier to get and share information as an NCWU member. NCWU has also started using our monthly membership meetings as working meetings for our upcoming programs. We hope this creates more opportunities for our members to be involved in planning programs like Women's Advocacy Day. Monthly membership meetings take place on the fourth Monday of every month.

We look forward to continuing to work with you as an NCWU member, and we hope to see your organization represented at our next membership meeting:
